With reference to your online application dated 28.06.2016 on the subject cited above, I am directed to convey the sanction for Composite Provisional Affiliation for Secondary School Examination and Senior Secondary School Certificate Examination of the Board for a period of three years w.e.f. 01.04.2017 to 31.03.2020. The following subjects have been sanctioned to be introduced at Senior Secondary classes:-

(a) Languages:

Hindi Core/ Elective, English Core/Elective, Sanskrit Core/Elective.

(b) Elective Subjects:

Accountancy, Biology, Business Studies, Chemistry, Economics, History, Informatics Practices, Mathematics, Music Hindi Vocal, Education, Physics, Political Science.

The above sanction is subject to fulfillment of following conditions:-

1. The affiliation Code Number allotted to your school is 531479. This may please be noted and quoted for any further correspondence with the Board.

The school will follow the syllabus on the basis of curriculum prescribed by NCERT/CBSE and text books publishing by NCERT/CBSE for the Middle Classes. The school will follow syllabus and courses as per scheme of studies prescribed by the Board for Secondary/Sr. Secondary School Examination and changes made therein from time to time.

3. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State Govt./UT Govt. from time to time.

4. The school must follow Uniform System of Assessment, Examination and Report Card for classes VI-IX from Academic Year 2017-18 onwards as per the Board's Circular No.: Acad-14/2017, dated 21.03.2017.

5. The school must submit it's information through Online Affiliated School Information System (OASIS) as per the Baord's Circular No: CBSE/Aff./4/Circular/2016, dated 10.11.2016, within 30 days from the receipt of this grant letter. Link for OASIS is available on Board's website: www.cbse.nic.in.

6. It is the case of switch over from State Board; the school is required to withdraw its affiliation from State Board as dual affiliation is not permissible. Also State Board classes IX and XI will not be continued w.e.f. 01.04.2017. However, for the Class X and XII Examination to be held in the year 2018, the school will sponsor its students for State Board only.

7. The school will provide additional suitable facilities for classes XI and XII, as per requirements laid down in the rules.

8. It will increase the number of equipments in the Laboratories/Workshops with adequate games facilities etc. in consonance with the requirements of the Board for Classes XI & XII.

9. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt from time to time.

10. The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation Bye-Laws of the Board which shall not in general exceed the optimum number as under from Pre-
